- Provision of a monthly A6 sustainably printed uniquely designed art piece for our 'Eco Hero' tier contributors.
- Monthly update email with a real-world impact tracker for every one of our customers.

Subscriptions can be purchased through our website and renewed on a recurring basis. Users may cancel their plans at any time.

The carbon credit options available to each subscription tier can be selected at checkout and may change at any time depending on a variety of external factors such as price and availability for the company to procure suitable credits.

PAYMENT POLICY

We accept payments via Stripe and PayPal. All subscriptions are billed on a recurring basis, as specified during the signup process.

- **Cancellations:** Users can cancel their subscriptions at any time through their account settings. Upon cancellation, no further payments will be charged, but previously paid fees are non-refundable.

As an alternative to court proceedings, disputes may be resolved through arbitration. Arbitration will take place in the United Kingdom and be conducted in English.

In the event of a dispute occurring wherein either party is subject to remuneration, written notification of the dispute shall be sent to the party in question and a period of no less than thirty days will be given to try and resolve the dispute without further formal action taking place. If, after this period, there has been a failure to reach a resolution, court proceedings may begin.

If the dispute is considered to be urgent or it is deemed appropriate that a thirty day window allow actions to be taken which may prove detrimental to the company, its assets or its reputation, immediate court proceedings may take place in lieu of the above suggested dispute resolution methods.
